

# Roadrunner Paintball

## Rental /Participation Agreement

Read carefully before signing

1. I accept for use "as is" the equipment rented by Roadrunner Paintball/Camp Morasha/NCSY (marker, goggles and Camo-suits), and accept full responsibility for the care of the equipment while it is in my possession.
2. I will be responsible for the replacement at full rental value of any equipment rented, if not returned to Roadrunner Paintball.
3. Roadrunner paintball/Camp Morasha/NCSY conducts paintball games and other games using among other things, marking pellets propelled co2 powered markers. I understand that this activity and transportation to and from it can be hazardous and involve risks that could result in personal injury, including eye injury or even death as well as damage to or loss of participant. This is conducted in variable terrain, which can include rocks, trees, steep inclines, streams, foxholes or other features, which can cause accident or harm to others or myself.
4. I clearly understand the requirement and necessity that eye goggles provided by Roadrunner Paintball/Camp Morasha/NCSY must be worn and kept firmly on the face at all times when and/or near the playing field. These risks have been explained to and I recognize, accept and assume them.
5. In consideration of Roadrunner Paintball/Camp Morasha/NCSY permitting me to participate in these marking pellet games and to be transported to and from them, I agree not to sue and hereby release Roadrunner Paintball/Camp Morasha/NCSY and their lessors, shareholders, owners, agents, servants and employees from any liability and all claims for personal injury, death or property damage or losses sustained by or for medical expenses in that incur arising from or related to the above activity, even if these are caused by the negligence, or any other type of conduct of any other aforesaid entities and person either individually or in concert with other parties.
6. I agree not to carry, use, consume or be under the influence of alcoholic beverages or drugs on or during today's games. I agree to obey all rules and regulations related to the activities in which I am about to engage and to follow fully the instructions of the field judges and other activity leaders.
7. I am in good health and at or above minimum age stated in Roadrunner Paintball's/Camp Morasha/NCSY advertising. I understand that strenuous physical exertion may be required and have no known physical disabilities or health problems, which will present any risk to my participation in the activities.
8. I permit the use of any photos, slides, film or sketches of me taken during the day's activity for publicity, advertising, promotions or other commercial purposes. The above agreement shall be binding on heirs, successors, assigns, administrators and executors.
